- m. Removed accumulated sand and brush from detention pond and rock installed
- n. Revised Community-Wide Standards
- o. New signs for pool parking lot
- p. Partially cleared HOA property on upper Mainsail
- q. Annual Halloween party (50-60 participants)

VI. 2018 Plans

The President announced the following plans for 2018:

- a. Pressure wash pool house and deck
- b. Replace some pool furniture
- c. Pave easement to hill
- d. Repair concrete table and benches on hill
- e. Continue clearing of HOA property on upper Mainsail
- f. Continue soliciting consent forms for Third Amendment
- g. Update website
- h. Other projects yet to be identified
